FOOD REVOLUTION DAY WITH JAMIE OLIVER PROMOTION OFFICIAL RULES

The Food Revolution Day with Jamie Oliver Promotion begins at 00:00 a.m. GMT on March 22, 2013 (the "<u>Promotion Start Date</u>") and ends at 12:00 p.m. GMT on April 30, 2013 (the "<u>Promotion End Date</u>") (such period referred to herein as the "<u>Promotion Period</u>").
